- 48 - ES&S ExpressVote Ballot Marking Devices - ADA - available for distribution and use on Election Day
- 36% of ExpressVotes not used for the General Election to be held November 5, 2024
- 89 - ExpressVotes purchased since February 2019
- 32- ExpressVotes kept at BOE office to deploy on Election Day if precincts experience lines/machine malfunctions
